MESSAGE FROM THE CHAIRPERSON

The Coldwell Community Foundation Inc. (CCFI) was incorporated in 2004 and the board has since been exploring, learning and discovering what a community foundation is all about and how tremendous the benefits can be to our local community, forever.

In 2011 the CCFI is planning to offer a bursary to be handed out at the high school graduation! Details will be worked out in the new year.

The CCFI is part of the Husky Community Rebate Program whereby cards are distributed by CCFI to individuals who patronize this fuel company and upon each fuel purchase, a percentage is given by Husky to the foundation. It is amazing how this adds up quarterly.

The CCFI was represented by two board members at the fall meeting in Portage. It was great to meet members from other foundations, learn how they got started and how they are making a difference in their respective communities. It was a very inspiring event!

We thank our outgoing board members, Brian Thomas, Monique Holm and Jason Young for all the work and effort they did over their term(s) of service. We welcome new board members Lorne Eyolfson, John Guttormson and Mark Eyolfson and look forward to their involvement in the community foundation movement.
